Early Strobridges:

She begins her book by referring to a Selectman's list of January 22, 1719 of "Sundry persons Strangers Lately come into the Town of Boston...", one of the listed being John Strobridge.

John Strobridge, of the foregoing list, was undoubtedly the same one who was married to Elizabeth Andrews, at Dorchester, Massachusetts, March 28, 1721-2, by Reverend Joseph Morse, and had son Samuel, born May, 1723. The above John may have been brother to the following: **William**, James, and Thomas Trobridge; brothers who came to Middleborough, Massachusetts, exact date of arrival not known.

Thomas Strobridge, brother of William, died August 6, 1724, age 25; is buried at Thompson Hill cemetery, Lakeville, Massachusetts.

James "Strawbridge", brother of William, bought of William a lot of land in Middleborough, Massachusetts, containing 18 1/4 acres; date of deed (this deed is in existence) March 5, 1738-9; paid 40 pound sterling.

James "Strowbridge", brother of William, died February 7, 1773, age 79; buried at Thompson Hill cemetery, Lakeville, Massachusetts. Neither Thomas nor James is known to have left any descendants, and both were probably unmarried.

According to family tradition, **William Strobridge**, ancestor of the family whose genealogy will be found in the following pages, was born about 1690, in some place near Londonderry, in the north of Ireland; married Margaret Henry in 1716; had daughter Mary, born in Ireland; came with wife and child to America between 1718 and 1722 (probably about 1719). He was a blacksmith, lived in Middleborough (West Parish, now Lakeville), Massachusetts where he died November 14, 1777, age 87. His wife died December 8, 1776, age 83.

From her earliest remembrance the author has been accustomed to hear that her Strobridge ancestors were "Scotch-Irish"--that is, persons of Scotch blood born in, or residents of, Ireland, and not until within a very short time has she supposed there could be any doubt about it, but of late the question whether she is justified in claiming a Scotch origin for those ancestors has arisen, and she is forced to admit that the objectors have all the evidence there is in their favor.

She has long know of the Trowbridge or Strobridge or Strawbridge family of Devonshire, England; but, supposing it to be a branch of an older one, to which the Scotch family also belonged, made no attempt to connect with it. Such investigations of the matter as she has been able to make, however, reveal no information concerning a Scotch branch, and the probability now seems to be that the early ancestors of William Strobridge, and of the various Strawbridges who are known to have come to America from Ireland, went to Ireland from England.

Having arrived at this conclusion, it may be well to give in this connection all that the author has learned of the Devonshire family.

[Note by Alonzo Dean Cook, May 23, 2006 - the author then goes on to site a book called Chapman's "Genealogy of the Descendants of Thomas Trowbridge, who came from Taunton, Somersetshire, England, to Dorchester, Massachusetts in 1636", discussing English ancestry, coat of arms, name changes in the family and so forth, until she gives some information about the family in America.]

The first reliable date in connection with **William and Margaret Strobridge** is from the Middleborough town records. The next one is from the records of the First Church (Cong.) of

Middleborough, and reads: "Sept. 9, 1722 [which evidently means the time he joined the church], William Strowbridge from Donaugh, Ireland, removed 1725 to West Parish [another part of the town, now Lakeville], Middleborough, died November 14, 1777, aged 87"; also: "Margaret Strowbridge, from Donaugh, Ireland, dismissed 1726 to West Parish; died December 8, 1776, aged 83."

There is no doubt about their having been Presbyterians, but it is well known that at the time it was considered imperative that a person should be a member of some church, and as there was then no Presbyterian church with which they could connect themselves, they did the next thing, joined the Congregationalists, and remained with them probably to the end of their lives, although their children appear to have been a few years later among the followers of Rev. John Morehead.

A deed to William "Strawbridge" of Middleborough, dated December 3, 1728, is recorded at Plymouth, Massachusetts, from which it appears that he did not at once become the owner of land. Other deeds dated September 23, 1729; February 12, 1731; April 18, 1733; July 1, 1736; August 1, 1741; May 1, 1742; November 17, 1743; June 30, 1744, November 11, 1747. (Those of 1741, '43, '43 and '47 read Strobridge, all the others Strawbridge.)

There are also four later deeds to William Strobridge. He is mentioned as a husbandman, and all the early deeds seem to be of woodland.

The author has seen the original deed from William "Strawbridge" of Middleborough, of 18 1/4 acres of land in Middleborough to James "Strawbridge"; consideration, 40 pound sterling; date, March 5, 1738-9. This ancient document is the property of Mrs. Harriet B. (Dean) Barstow, of Taunton, Massachusetts, a great-granddaughter of William Strobridge, senior. A facsimile of the signature to this deed is here given. For some time the author was inclined to the opinion that the early members of the family wrote the name Strawbridge, and that Strobridge was a comparatively recent mode of spelling; but the signature to this deed disposes of the question, though why the name should be found spelled Strawbridge in the very document signed Strobridge is inexplicable. Rev. John Morehead evidently considered the name identical with Strawbridge, for in his records of the baptisms of William Strobridge's grandchildren, he invariably wrote it Strawbridge.

[7]James Strobridge, son of Wiliam[1], was born 1729 in Middleborough (West Parish, now Lakeville), Massachusetts; married Mary Gordon of Voluntown, who was born at Voluntown October 6, 1733, and was a sister of the wife of his brother Henry. In 1754 Moses Inglee of Halifax, Massachusetts deeded a piece of land containing 22 1/2 acres to James Strowbridge, Junr. ["Junr" seems to have been added to his name in the document, in order to distinguish him from his uncle, James Strobridge, who was then living at Middleborough.] This land was afterwards conveyed to Henry Strobridge, an older brother of James, and by him deeded in 1788 to his daughter, Anna Dean. James Strobridge removed to Northfield, Massachusetts, previous to or in 1783, and died there October 23, 1811, age 82; his wife died March 3, 1817, age 84; both are buried and have tombstones in an old cemetery at Northfield.

He married (1) at Claremont, New Hampshire, December 2, 1784, Julia Tuttle, who was born at Farmington, Connecticut on March 3, 1767 and died at Solon, New York on April 4, 1824, age 57; then married (2) at Solon, New York on November 1, 1826, Bethshua Crawford. He lived in Claremont, New Hampshire for a few years after his 1st marriage. Not far from 1797 Mr. Strobridge moved from Clarendon, Vermont to Solon, New York where he was unfortunate in losing his farm for the second time. Besides being a farmer, he worked at the saddlery trade and taught the same to all his sons. He died at Potter, Yates, New York on March 20, 1837.

After nearly 2 years service in Virginia was commissioned senior major in 2d Ohio Heavy artillery, and then lieutenant-colonel of same regiment; served 2 years in Tennessee, and was honorably discharged September 1865; is now (1891) in the fire insurance business at Cincinnati; no children.
